**J U D G M E N T**

**THIS MOTION**, made by the Plaintiff, the Canadian Private Copying Collective (CPCC) for Default Judgment in favour of CPCC against the Defendants 2138557 Ontario Inc., 2175574 Ontario Inc. and Kuo Jung chen (aka Chen Kat Yung) (collectively, the **Non-Settling Defendants**) was heard this day, at Toronto.

**ON READING** the Amended Statement of Claim in this action, the Notice of Motion, the Affidavit of Laurie Gelbloom sworn March 6, 2014 and the Factum of CPCC, the Non-Settling Defendants having been noted in default, and on hearing the submissions of the lawyer for the Plaintiff,

1. **THIS COURT ORDERS** that Default Judgment be and is hereby granted in the amount of \$3,306,471.80 in favour of the Plaintiff against the Non-Settling Defendants, *fmp* *less any amounts recovered from any jointly liable co-defendants.* ✓ *fmp*
2. **THIS COURT ORDERS** that the Non-Settling Defendants shall pay to the Plaintiff a penalty equal to five times the amount of Levies payable to the Plaintiff, namely \$16,532,359.00.
3. **THIS COURT ORDERS** that the Defendant pay the costs of this motion in the amount of \$ 5,461.62, all inclusive ✓ *fmp*

4. **THIS COURT ORDERS** that the Defendant pay the sum of \$616,881.57 in pre-judgment interest.

5. **THIS JUDGMENT BEARS POST-JUDGMENT INTEREST** at the rate of three (3%) per year commencing on March 24, 2014.


